This purchase agreement is a legally binding contract for the sale of one kitten/cat between Bare Necessity Sphynx Cattery (the seller) and _____ (the buyer) entered into on this _____ day of _____, _____

Bare Necessity Sphynx Cattery requires a \$500 non-refundable but transferable deposit to reserve a kitten/cat. This deposit will go towards the total agreed upon price.

All shipping cost will be paid by the buyer. The seller is not liable for the kitten/cat if lost or stolen after the acceptance by the airline carrier or pet courier. Once the kitten/cat is given to the airline carrier or pet courier the buyer takes all responsibility to deal directly with the airline or courier if kitten/cat is lost, stolen or damaged resulting in the mortality of the kitten/cat.

Please note: No feline is completely hairless. It is understood that the degree of hairlessness of the Sphynx cat varies from cat to cat and sometimes from season to season. No sphynx is truly completely hairless. Hormones and genetics play an important role in degree of hairlessness and even though a kitten may be almost hairless when it is sold, it is possible that the kitten could develop some hair after being neutered/spayed or, as it grows older. It is impossible to guarantee that any sphynx kitten/cat will not grow hair at some point and time.

The conditions of this sale are as following:

- (1) The price of the above kitten/cat includes a US \$500 nonrefundable but transferable deposit due for reservation of kitten/cat. Balance shall be paid in full when the kitten/cat is ready to leave the sellers home.
- (2) The seller guarantees that health of kitten/cat for 72 hours after transfer to buyer. If there are any health concerns buyer agrees to have kitten/cat examined by a licensed veterinarian within the 72 hours. Buyer agrees to notify the seller within the 72 hours of any adverse findings. It is recommends that the kitten/cat is taken to the46 Buyer is responsible for all veterinary fees from the date of shipping or pick up. Seller will

guarantee against genetic illnesses resulting in death up to one year of age. A necropsy will be required for proof.

(3) Bare Necessity Sphynx is an HCM (Hypertrophic Cardiomyopathy) scanning cattery but scanning is only a tool and not a heart disease test. Clear scanning parents can still produce positive offspring. Heart disease is not always genetic/hereditary it may even develop secondary to another illness such as hypertension or hyperthyroidism. Please note there is not a DNA heart test available for the sphynx breed and HCM can show up at any age. The sphynx breed and has been known to develop heart disease and you must be aware and agree to the special needs of this breed. Pet insurance is always recommended.

(4) The buyer agrees to provide adequate health care by a licensed veterinarian. The sphynx is an indoor only cat. Under no circumstance shall the kitten/cat be declawed. Kitten/cat will come dewormed and up to date on age appropriate vaccines. Kitten will also be altered when going to new home. Buyer will be responsible for taking kitten to either their veterinarian or our veterinarian for post op care from the spay/neuter surgery.

(5) Deposits are non-refundable. After kitten/cat goes to its new home there are NO REFUNDS.

Odd-eye kittens are rare and sold at a higher price

.Bare Necessity Sphynx Cattery reserves the right to cancel this sale and contract of kitten/cat for any reason. Seller has the conditional right to reclaim kitten/ cat without refund of purchase price for any breach of contract. Breach of this contract will have a penalty fee which is the purchase price of the above kitten/cat.

Any legal action which may arise under the terms of this contract will be brought in Riverside County, California. Buyer shall be liable for any court costs and related charges including attorney fees associated with the seller enforcing the terms of this contract.

Signatures and dates below indicate full agreement to ALL terms and conditions of this purchase contract. No other warranties or guarantees are proved other than those specifically outlined above. This document is a legal and binding contract. The laws of the state of California shall be controlling.
